Priorities:

Leave a Lasting Legacy (Janet, Alan)

Janet and Alan talked through a number of changes to the Leave a Lasting Legacy (LLL)
 Operating Manual and presented two motions;

Motion 1: That Council make a recommendation to the Congregation for the approval of a change to the year-end distribution of undesignated bequests and memorial gifts received by the Leave a Lasting Legacy Fund, such that:

- (a) 20% will be distributed to the Property Maintenance Fund (changed from 10%);
- (b) 20% will be distributed to operations;
- (c) 5% will be distributed to National & Global UCC Outreach (M&S) (changed from 15%);
- (d) 5% will be distributed to Local Outreach; and
- (e) 50% will remain in the LLL Fund.

with such change in distribution to take effect for ESG's 2024 fiscal year end.

updated Operating Manual to be circulated to the Congregation prior to the Congregational Meeting scheduled for April 14, 2024.

• Gord presented the following motion:

Finance moves that the additional fee charged by the United Church of Canada of ¼% of all non-property assets be paid directly from the funds against which the fee is being calculated. And that Council approves this recommendation from Finance and directs Trustees to proceed with enacting any necessary changes to implement this additional transfer to Operations.

- Results are generally positive to budget and ahead of prior YTD figures;
- Rental income 34% ahead of last year;
- Music score over budget not approved by council.

M & P (Bob)

• Bob presented a motion to increase the fee paid per call to the ESG choir section leads to bring them into line with fees paid by other Toronto churches.

Moved that the fee per call for ESG Choir section leads be increased from \$62.50 to \$75 effective Mar 1st.

- Costs can be covered from Worship and Property budgets.

- Moving into their apartment on Mar 1st;
- Kristen has raised over \$50k total and significant donations of furniture have been received.
